This information can include: Social Security number and credit scores Payment history and transaction or loss history Overdraft history and credit history When you are no longer our customer, we continue to share your information as described in this notice.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. PeoplesChoice Credit Union has no affiliates
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Non-affiliates we share with can include insurance companies
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include insurance companies
